### 6.3 Methods and materials for containment and cleaning up

- Methods for cleaning up : Clean with detergents. Avoid solvents.  
Contain and collect spillages with non-combustible absorbent materials, e.g. sand, earth, vermiculite, diatomaceous earth and place in a suitable container. One possible (flammable) decontaminant comprises water (45 parts by volume)/ethanol or isopropanol (50 parts)/concentrated (d: 0.880) ammonia solution (5 parts).
