### SECTION 4: First aid measures

#### 4.1 Description of first aid measures

### 6.3 Methods and materials for containment and cleaning up

One possible (flammable) decontaminant comprises water (45 parts by volume)/ethanol or isopropanol (50 parts)/concentrated (d: 0.880) ammonia solution (5 parts). A non-flammable alternative is sodium carbonate (5 parts)/water (95 parts).
